MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter referred to as MOU) is made on 20th May 2025 by and between

GEETA INSTITUTE OF LAW, PANIPAT DELHI NCR, INDIA

AND

THE FEDERAL STATE BUDGETARY EDUCATIONAL INSTITUTION OF HIGHER EDUCATION "NORTH CAUCASIAN STATE ACADEMY" (NCSA), CHERKESSK, KARACHAY-CHERKESSIA, RUSSIA

In consideration of the mutual commitments herein, the Parties agree as follows:

I. Purpose

This Memorandum of Understanding (MOU) establishes a framework for cooperation and collaboration between Geeta Institute of Law Panipat Delhi NCR and The Federal State Budgetary Educational Institution of Higher Education "North Caucasian State Academy".

Both institutions share a commitment to fostering International Understanding, Promoting Academic Excellence, and facilitating Mutually Beneficial Activities.

II. Areas of Cooperation

The areas of cooperation between Geeta Institute of Law (GIL) and North Caucasian State Academy may include:

- ❖ Student Exchange Programs: Facilitating the Exchange of Undergraduate and Post Graduate Students for Study, Research, or Internships.
- * Faculty Exchange Programs: Promoting the exchange of faculty members for Teaching, Research, and Professional Development.
- ❖ Joint Research Activities: Encouraging collaborative Research Projects in areas of Law and Humanities.

- * Sharing of Academic Materials: Exchanging Academic Publications, Research Materials, and Other Scholarly Resources.
- ❖ Joint Conferences and Seminars: Organizing Joint Conferences, Seminars, Workshops, and Other Academic Meetings.
- Online Education Programs: Collaborating on the development and delivery of Online Programs for promoting the ability towards the research.

III. Responsibilities of Each Institution

- Geeta Institute of Law (GIL), Panipat Delhi NCR will be responsible for:
 - 1. Identifying and Supporting Faculty and Students Participating in Collaborative Activities.
 - Providing necessary Resources and Facilities to Visiting Faculty and Students from North Caucasian State Academy (NCSA), subject to availability and the Institution Policies.
 - 3. Promoting the Collaborative Activities within Geeta Institute of Law.
- The Federal State Budgetary Educational Institution of Higher Education "North Caucasian State Academy" (NCSA) will be responsible for:
 - 1. Identifying and supporting faculty and students participating in collaborative activities.
 - 2. Providing necessary resources and facilities to visiting faculty and students from Geeta Institute of Law, subject to availability and Institute policies.
 - 3. Promoting the collaborative activities within the Institution.

IV. Implementation

The implementation of specific activities under this MOU will be determined through separate written agreements. These agreements will outline the details of each activity, including:

- The Scope of Work
- The Responsibilities of Each Party
- The Budget and Funding Arrangements
- The Timeline for Completion
- Intellectual Property Considerations
- Other Relevant Terms and Conditions

V. Financial Arrangements

This MOU does not create any financial obligations for both either Geeta Institute of Law (GIL) or North Caucasian State Academy (NCSA). The funding of specific activities will be determined and agreed upon in the separate written agreements mentioned in Section IV.

VI. Intellectual Property

Intellectual property rights arising from collaborative activities under this MOU will be addressed in the separate written agreements mentioned in Section IV. The parties will seek to protect and share intellectual property in a fair and equitable manner, consistent with applicable laws and regulations.

VII. Amendments

This MOU may be amended or modified at any time by mutual consent of both parties. Any amendments must be in writing and signed by authorized representatives of both Institutions.

VIII. Confidentiality

Each party agrees and acknowledge that this MOU (and the information it contains) is confidential and undertakes not (without the other Party's prior written consent) to disclose its existence or terms (in whole or in part) to any third party or to use it (in whole or in part) for any purpose other

than to fulfil the objectives set out above. If either party desires to use or disclose any confidential information belonging to the other, the Parties shall first execute a confidentiality agreement on terms to be agreed between them.

IX. Settlement of Disputes

In the event of any dispute emerging, the both parties shall make the best efforts to solve the problem amicably and promptly between themselves.

X. Term and Termination

This MOU will become effective upon the date of signature by both parties and will remain in effect for a period of 5(Five) Years. It may be renewed for additional periods by mutual written agreement of the parties.

Either party may terminate this MOU by providing 2(Two) Months' Written Notice to the other party. In the event of termination, both Institutions will endeavor to complete any ongoing activities in a manner that minimizes disruption to the participants.
